

LeBoeuf Township Supervisors Meeting – January 7, 2019

The LeBoeuf Township Supervisors Regular Meeting was held January 7, 2019. The meeting was called to order at 9:23 a.m. Present were James Glover, Michael Porter, Michael Whitman, Craig Hall, J.R. Hanas, Drew Francisco and Catherine Wise.

James Glover motioned to approve the minutes from the December 12, 2018 meeting, Michael Whitman seconded. All voted yes.

James Glover moved to submit for audit the Treasurer's Report for December 20, 2018- General Fund \$79,363.53, State Fund - \$44,120.71, Cell Tower Escrow - \$8,434.13, Line of Credit Remaining: \$57,675.57 . Michael Whitman seconded. All voted yes. Motion carried.

James Glover moved to submit for audit the Treasurer's Report for January 3, 2019- General Fund \$82,438.11, State Fund - \$38,795.70, Cell Tower Escrow - \$8,437.71, Line of Credit Remaining: \$57,675.57 Michael Whitman seconded. All voted yes. Motion carried.

James Glover moved to approve and sign Ordinance #1 of 2019 – Wireless Communications amendments.

The ECATO Committee and Meeting sign-up sheet was presented.

A letter from the Erie County Planning Commission asking for nominees was reviewed. The Supervisors would like to meet with Michelle Brooks concerning funding for road improvements.

Road Foreman Report: Pipes and a Catch Basin was ordered for Willey Road. Trees were trimmed on Porter Road, Smith Road, etc. 411's were spread on various roads due to road deteriorating. The Mack Tandem needs repairs. Discussion was held on Tar & Chip for Union LeBoeuf Road and/or Old Meadville Road. LeBoeuf Township was denied 2 grants from the Erie County Conservation District for 2019.

Correspondence was read and reviewed.

Michael Whitman motioned to Ratify Bills and Payroll for December 20, 2018 and January 3, 2019. James Glover seconded. All voted yes.
